

# NameBright.com Two-Factor Authorization Recovery Form

The following form must be signed and notarized by a notary of the public, and submitted with a current and valid government issued ID such as a driver's license, photo id or passport. A specific explanation must be included to explain and summarize why you require this two-factor authorization to be updated on your behalf.
